2.5.2. Mechanism to deal with internal examination related grievances is transparent, time-bound and efficient

> IBSAR School of Law has established an independent committee to look after the internal examination process. This committee ensures timely conduction of internal assessment with proper discipline. It also overlooks the examination supplies, evaluation by examiners, and results at Institutional level. All grievances regarding the internal assessment can be directly put forward to this committee using the internal Examination Grievance Form. The committee regularly meets, plans the activities, and solves any grievances with fair judgment. The Institute also ensures its confidentiality and fairness. The exam-related grievances are addressed by the committee and it ensures timely response to the students.

A. Exam grievances like

- 1. Hall ticket is not generated
- 2. Spelling mistakes in the name of the student or seat number wrongly printed
- 3. Course fees or exam fees are charged higher as per the student's view.
- 4. Result not declared in stipulated time due to some unavoidable issues.
- 5. The student is absent from the exam
- 6. The subject mentioned in the timetable or printed on the hall ticket might be wrong)
- 7. Discrepancies regarding exam questions.
- 8. Disagreement regarding Exam Evaluation.
- 9. Concerns about the accuracy and fairness of the exam grading system.

B. Handling University related grievances

University-related grievances like timely conduction of internal exams, mismanagement of internal examination mark sheets, and technical problems are handled by the committee. The Committee discusses the grievance in the scheduled meeting and finds a timely solution. The grievance report along with the solution is forwarded to the University for further action. The institute ensures timeliness for submission of university grievances and after the responses are received from the University, the same is communicated to students.

• C. College-level grievances

- A College-level grievance committee deals with issues related to examinations at the college or at the higher education level. The college ensures that the internal examinations are conducted as per the guidelines given by the university. Grievances typically include grading disputes, exam administration issues, mismanagement, scheduling conflicts, academic misconduct allegations, incomplete or incorrect exam materials, etc. Response to exam-related grievances is resolved within the stipulated time.
- The specific grievances considered by a college-level exam committee may vary based on the college policies and procedures.


